Schrems II Judgement v1.0

September 2021

A ruling by the Court of Justice of the European Union, requires organizations to ensure there is a data protection equivalent to GDPR beyond EEA countries when sharing personal data.

- Organizations exporting data must decide whether non-EEA countries offer GDPR equivalent protection
- Where there is not equivalent data protection, supplementary measures must be taken
- All data exporters need to document their data protection approach as clarified by the European Data Protection Board
- Organizations can expect finds of up to €20m or up to 4% of the total worldwide turnover of the previous financial year
- · Schrems II puts additional demands on organizations to maintain data compliance globally
